

## Alexander's Completes \$350 Million Refinancing of 731 Lexington Avenue Retail Space Realizing \$26 Million of Net Proceeds

PARAMUS, NJ -- (Marketwired) -- 08/05/15 -- ALEXANDER'S, INC.(NYSE: ALX) announced today that it has completed a \$350 million refinancing of the retail portion of 731 Lexington Avenue. The interest-only loan is at LIBOR plus 1.40%, currently 1.59%, and matures in August 2020, with two one-year extension options. The Company realized net proceeds of approximately \$26 million after repaying the existing \$320 million 4.93% fixed-rate mortgage and closing costs.

Alexander's, Inc. is a real estate investment trust that has six properties in the greater New York City metropolitan area.
